

# BUILD Volunteer Expense Claim Form 2017-18

Volunteers giving their time and support to BUILD are encouraged and entitled to claim back out-of-pocket expenses associated with their roles and responsibilities, as agreed with their service coordinator. If volunteers wish to donate back their expenses, this can be done via the gift aid process, which allows us to claim back up to 25p for every £1 donated. Expenses are as follows:



Use of a private car insured for volunteering purposes: 25p per mile travelled on BUILD volunteering towards fuel costs only.

Public transport: The equivalent of the cheapest, and most direct, return fare on production of a valid ticket/receipt.

Taxi fares: These will only be paid for volunteers with disabilities and by prior agreement with the service coordinator to holders of an authorisation letter setting out the terms of the arrangement.

Car parking: Up to a maximum of £3.20 where a park and ride option is not used or prior agreement reached with a service coordinator.

Food and drink: Only refundable where an activity exceeds 3 hours in duration.

Activity costs: By prior agreement with a service coordinator.

**Expense claims should be submitted monthly using this sheet, with receipts attached. Expenses will not be paid without this form being completed. To reduce the costs to BUILD, all expenses will be paid directly into a bank account. Please supply these details to us so we can arrange for payment to be made.**
